

WESTIE RESCUE AND PLACEMENT OF NORTHERN CALIFORNIA Foster Care Agreement



As a Foster Care volunteer for Westie Rescue and Placement of Northern California (WRAP), I agree to comply with the following:

- I understand that although the foster care Westies are in my care, they will remain the property of WRAP. I agree to return all Westies in my care to WRAP on the date specified by the Rescue Coordinator, as well as any unused supplies and medications supplied by WRAP or the veterinarian who treated this Westie.
- I **WILL NOT** sell, give away, adopt out or otherwise dispose of any foster Westie in my care.
- I am aware that the WRAP will provide me with or reimburse me for food, supplies and medical costs for the Westie I am fostering for them. These costs must be approved by the Rescue Coordinator prior to reimbursement.
- I agree to provide regular food, water, exercise, medical care, shelter, socialization, grooming (bathing and brushing) and any other requirements arising from the care of a foster animal.
- I will strictly follow the instructions given me by the Rescue Coordinator and the veterinarian regarding the care of my foster Westie.
- I agree to properly and regularly administer medication that has been prescribed by a veterinarian to my foster Westie.
- I agree to keep all appointments made with the veterinarian and the Rescue Coordinator. If I cannot keep an appointment, I agree to contact an appropriate Rescue contact early enough that alternate arrangements can be made.
- I understand that costs stemming from medical treatment of a foster Westie will be reimbursed to me.
- I understand that any medical costs incurred by a personal pet's exposure to a foster Westie will not be reimbursed to me. I will take the necessary precautions to protect my personal pets and Foster Westies from disease.
- I agree to report any change in a foster Westie's health or behavior in a timely manner to the Rescue Coordinator.
- I agree to report the death of any foster Westie to the Rescue Coordinator. I will also return the body of this animal at once for evaluation.
- I understand that I will not be reimbursed for any property damage done by the Westie I am fostering.
- I will use diligence when introducing young children to any Westie in my care.
- I understand that WRAP makes every effort to place foster Westies in permanent homes. However, WRAP cannot guarantee the time frame for the placement of any animal.
- I agree to allow a WRAP representative to visit my home if the welfare of the foster Westie in my possession is questioned. I understand that this visit may be unannounced.
- I understand that I may be terminated from the Foster Care Program without notice if deemed necessary by the Rescue Coordinator.

When you take custody of a Westie to be fostered, you will be required to sign the following release clause:

I/We, the undersigned, are voluntarily accepting for foster care a West Highland White Terrier(s) from Westie Rescue and Placement of Northern California.

In consideration of receipt of this West Highland White Terrier(s) or Mix known as: _____

I/We, the undersigned voluntarily and knowingly execute this contact and general release with the expressed intention of affecting the extinguishment of obligations as herein designated.

The undersigned, with the intention of binding themselves, their heirs, executors, administrators and assigns, do hereby expressly release and discharge Westie Rescue and Placement of Northern California, and all officers, directors, or members of the aforesaid organization and their heirs, executors, administrators, and assigns, from all claims, demands, actions, judgments, and executions which the undersigned ever had, or has, or may have, or which their heirs, executors, administrators, or assigns of the undersigned may have or claim to have against Westie Rescue and Placement of Northern California, created by or arising out of any damage or injury, including but not limited to both personal and property injury or damage, caused by this West Highland White Terrier hereto fore mentioned.
